This Terms of Use is last updated on 7 November 2025.

Welcome to the Merz Aesthetics* website where You can experience better. Merz Aesthetics offers online resources, such as this website ("Site"), to provide You general information about our products and services. We provide these Terms of Use and our Merz Aesthetics Privacy Policy (<https://merzaesthetics.com.sg/wp-content/uploads/Merz-Aesthetics-Privacy-Policy.pdf>), to outline our relationship with You (our Merz Aesthetics Privacy Policy forms part of these Terms of Use). **By using the Site, you agree to accept and abide by these Terms of Use and agree to the terms of Merz Aesthetics Privacy Policy.**

THESE TERMS OF USE ARE A CONTRACT BETWEEN YOU AND MERZ AESTHETICS. THIS CONTRACT GOVERNS YOUR USE OF THE SITE AND ANY AND ALL PAGES, OPTIONS, AND SERVICES ON THE SITE.
